NOTIFICATION

GUJARAT TOWN PLANNING & URBAN DEVELOPMENT ACT, 1976

No. GH/V/328 of 2015/UDA-102014-5026(1)-L WHEREAS, Navsari Municipality was designated as area development authority under sub section (1) of Section 6 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) (hereinafter referred as "the said Act") vide Government notification No.GHB-20-UDA-1177-646(2)-Q Dated:30.01.1978.

AND WHEREAS after designation of Navsari Area Development Authority and development within the surrounding area has increased which requires plan development of the area.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1), (2), (2-A) of section 22, sub-section 5 of 22, sub-section 3 of section 23 and section 108 of the said Act, the Government of Gujarat hereby:-

- (i) Declares the areas specified in column 3 of the schedule appended here to be the Urban Development Area. (hereafter referred as "the said Urban Development Area")
- (ii) Amalgamates the areas of Navsari Area Development Authority and defines the development areas of specified in column 3 of the schedule for Navsari Urban Development Authority and to be the limits of such development area.
- (iii) Constitutes the Authority for the said Urban Development Areas to be called "Navsari Urban Development Authority" and shall consist of the following members, and declares Navsari as Authority's headquarter.
