WHEREAS under Government Notification, Panchayats Housing and Urban Development Department No.GH/P/ 27 of 79/TFS-2578-8635-Q dated the 29th November, 1979 the Government of Gujarat had, in exercise of the powers conferred by sub-section (2) of section 48 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) (hereinafter referred to as "the said Act") sanctioned the draft town planning scheme, Navsari No.1 (Station Area) (hereinafter referred to as "the said draft scheme" submitted to it by the Navsari Nagarpalika Navsari Area Development Authority);

AND WHEREAS in exercise of the powers conferred by section 50 of the said Act, Government of Gujarat appointed the Town Planning Officer for the said draft scheme;

AND WHEREAS under Government Notification, Panchayat Housing and Urban Development Department No.GH/P/72 of 1983/TFS-2582-993(83)-L dated 14th April, 1983 the Government of Gujarat in exercise of the powers conferred by section 65 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976)

has sanctioned the town planning scheme Navsari No.1 Preliminary;

AND WHEREAS the Town Planning Officer has submitted to the Government of Gujarat, the Town Planning Scheme Navsari No.1 (Station Area) (Final Scheme) (hereinafter referred to as "the said final scheme") as required under sub-section (2) of section 52 and sub-section (2) of section 62 of the said Act;

AND WHEREAS under the Government Notification No.CH/V/160 of 1989/TPS/2588/2191(89)-L dated 19-9-89 Government has carried out the correction in the sanctioned preliminary Town Planning Scheme Navsari No.1 under Section 70 of the Act.

NOW, THEREFORE, in exercise of the powers conferred by section 65 of the said Act the Government of Gujarat hereby:-

- a) sanctions the said final scheme"
- b) states that "the said final scheme shall be kept open to inspection by the public at the office of the Navsari Nagarpalika (Navsari Area Development Authority) Navsari during office hours on every day except, Sundays and holidays; and
- c) fixes the 22<sup>nd</sup> day of January, 1990 as the date for the purpose of clause (b) of sub-section (2) of the said section 65.
