WHEREAS, under Government Notification, Urban Development Department's No. GH/V/66 of 1987 -TPS-2585 - 729- L, dated 18.3.87 the Government of Gujarat had, in exercise of the powers conferred by sub-section (2) of section 48 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) (hereinafter referred to as "the said Act") sanctioned the draft town planning scheme, Navsari No.3 (Gandevi Road, East Tighara Area) (hereinafter referred to as "the said draft scheme") submitted to it by the Navsari Nagarpalika;

AND, WHEREAS, in exercise of the powers conferred by sub-section (1) of section 51 of the said Act, the Government of Gujarat appointed the Town Planning Officer for the said draft scheme;

AND, WHEREAS, under Government Notification, Urban Development and Urban Housing Department No. GH/V/15 of 1992/TPS-2590-3558(91) - L, dated 22.1.1992 the Government of Gujarat, in exercise of the powers conferred by Section 6 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976), has sanctioned the Town Planning Scheme Navsari No.3 (Gandevi Road, East Tighara Area) Preliminary;


AND, WHEREAS, the Town Planning Officer has submitted to the Government of Gujarat, the Town Planning Scheme Navsari No.3 (Gandevi Road East Tighara Area (Final Scheme) (hereinafter referred to as "the said final scheme") as required under sub-section (2) of section 52 and sub-section (2) of section 62 of the said Act;

NOW, THEREFORE, in exercise of the powers conferred by section 65 of the said Act the Government of Gujarat hereby:-

- a) sanctions "the said final scheme"

- b) states that the said final scheme is kept open to inspection by the public at the office of the Navsari Nagarpalika during office hours on every day except, Sundays and holidays; and
- c) fixes the 20th day of March, 1999 as the date for the purpose of clause (b) of sub-section (2) of the said section 65.
